

EXPOSE FBI CORRUPTION FOR FUN AND PROFIT

Cynthia Jeanne Lee MD is asking members of the hacking community to help her expose FBI corruption coordinated with insurance industry efforts to block access to the courts.

I'm asking because access to attorney representation for 1) First Amendment access to the courts in disputes with the government and 2) court access for insurance contract disputes is dependant on integrity of access via the Internet, U S mail, and telephone. I've seen all three compromised. I've come to believe that the real purpose of the Patriot Act is to monitor and control persons who can expose government corruption and prevent lawsuits.

I am a physician who discovered that the insurance industry and pharmaceutical industry are colluding with the Federal and State governments to 1) manipulate how medical care is practiced to the extent not even physicians are capable of receiving competent diagnosis/treatment 2) control access to the courts by setting up plaintiff attorneys who are actually controlled by the insurance industry.

I was not and currently am not internet savvy. I am offering to barter a percentage of the financial proceeds from the insurance suits that would result from finding an attorney who is not controlled by the insurance industry and can prevail against the government/insurance industry collusion.

INSURANCE INDUSTRY MANIPULATION INCLUDED:

Faked insurance claims submitted in my name Cynthia Jeanne Lee MD
And employees bribed or intimidated into depositing the resulting insurance checks
Allegations by Farmer's insurance that I engaged in fraud in relationship to a mold/water damage claim
My attorney had insurance industry conflicts of interest he did not reveal and went into the State government and went after my license
My malpractice insurer had major conflict of interest in that other physicians also insured by them had misdiagnosed me.

GOV'T MANIPULATION INCLUDED (BUT NOT LIMITED TO)

Internal revenue service manipulation of my tax preparer associated with Postal Service interruption of the timely submission of income tax documents
Failure of Postal inspectors to reply to complaint of fraudulent insurance submissions
Eventual seizure of my homestead (had clear title) in Texas (after I was stalked out of it with physical intimidation/entrances while I was asleep)
Refusal of FBI to investigate my allegations, refusal to keep records of my requests, refusal to let me visit SF office and file complaint, no response to faxes
Failure of members of the House and Senate to assist
Assaults of various kinds intended to make me sound paranoid if I complained
Blocking of access to medical care (possibly related to my serving as an expert witness in a medical malpractice case)
Deaths of numerous people related to this case including 2 attorneys (my brother and Robert Provan) and the son of another, deaths of 2 physicians and one legal worker Municipal judge in Oregon w part-time law practice alleged he was ACLU contractor Blocking of access to ACLU here in SF and other civil rights group in Austin and at least one attorney in Sacramento

White Hat Geek Needed for Physician vs. Insurance Industry Malfeasance

In the 1990's, the insurance industry hired Bush 1's Drug Tsar, a retired general, to link the industry with law enforcement. Insurers could now turn over the names of "suspected insurance cheats" and get the government to do their investigations for them. In a new book, *Delay, Deny, Defend*, by a law professor for the lay public, he lays out the unusually lax criteria used to decide whose names to turn over (without the named individuals being informed of their "suspicious" status). I'm asserting that I was a political hit by the insurance industry to protect other vested interests. 1) I tried to have the right to competent expert in Texas courts enforced after a grossly incompetent expert was used on me in a successful effort to remove thousands of dollars of my assets (retirement funds). 2) I was forced to sue my private disability insurers after multiple physicians misdiagnosed the results of an occult craniofacial birth defect as psychosocial stress instead of recurrent nocturnal hypoxia causing hypoxic encephalopathy from which it was difficult to recover. In ALL the above cases, I was deliberately set up (by "trusted" legal counsel) w attorneys w close ties to the insurance industry, a fact that was hidden from me and I assert constitutes a RICO behavior.

I was stalked out of my homestead in Austin Texas after repeated assaults and my home/motel rooms entered illegally repeatedly and have been on the road ever since. The stalking occurred after going to the FBI because I discovered someone in my medical office had apparently sent in fraudulent insurance claims during my absence. Neither the FBI nor Postal Inspectors deny that that I was under investigation for insurance fraud (of which I was never apprised). These entities have refused me any cooperation. Local police behaviors demonstrate federal influence.

FINANCIAL INCENTIVE: I will barter a negotiable percentage of the proceeds from the insurance cases, one of which was for >\$500,000 in actual damages before punitive damages and legal fees. The other insured my overhead for my medical office and their failure to honor the contract resulted in the loss of my business.

REQUIRED: research attorney backgrounds for conflicts of interest/fake credentials, litigation expertise, manage my web presence, add explanatory info for misleading info, be creative in protecting our unobstructed right to sue for breach of contract/government cooperation w illegal corporate maneuvers, locate/educate interested parties for Amicus actions and publicity, watch for obstruction to using the web, maintain records of your efforts

In Short, NO SUCCESSFUL LITIGATION, NO REWARD

Please post for me on bulletin boards as, in order to prevent further malfeasance/obstruction by conflicted persons, I will contract w multiple parties, reserving the highest percentage to the individual(s) who locate the successful attorney but some \$\$\$ to those who build web interest/find support groups

THINK: Anyone's business could be hit w surreptitious insurance fraud charges and be investigated and/or set up by gov't/corporate contrivance but it is especially pernicious when it is a physician who is trusted w your personal information. That is what a jury might consider! That would be a possible use of the Patriot Act or FISA with individuals who have contacts w persons from the Middle East, like my practice did. My email, U S Mail, and telephone has been compromised when I attempt contact w attorneys. U S mail to attorneys not acknowledged. Registered mail to the ACLU was signed for by "FELON" and responses were irregular or bogus.

I can be located at the SF Public Library usually reading in the Deaf Center on the first floor (middle aged WF long brown hair, orange WINDWALL jacket, Briggs & Riley 22inch case), or the 3rd floor at 150 Golden Gate .Tenderloin Tech Center using the free computers, or I also eat at St. Anthony's almost daily. An experience not to be missed. All 4 "Food Not Bombs" events *Noisebridge 2169 mission*

I want my case to be the index case to show how the insurance industry is manipulating public perception, probably including illegal coordination w some plaintiff's attorneys (or, as in my case, actually pretending to be plaintiff's attorney). I can also show you how they are also providing support for pharmaceutical industry efforts to foster missed diagnoses (which raises their prescription drug profits enormously) via government/industry collusion in the medical malpractice arena. How else would a physician w obstructive sleep apnea be misdiagnosed by her fellow physicians so long? Think AMICUS

To protect the people helping me, until the case has been successfully litigated, I do not need to know your name(s) and will agree to a video being made for you to safeguard your identity/right to remuneration. I am unable to maintain the records myself due to circumstances related to illegal surveillance and 4th amendment seizure.
