Dear Mr. Hill,

I write requesting consideration of representation. This is an involved legal situation that takes one deep into the black heart that is the collusion between the Republican Party of Texas in collusion with the U S DOJ and the insurance industry. Unfortunately, it may also involve attorneys also identified with the Democratic Party. I'm not exactly sure about that. It certainly is a politically connected case, in an unconstitutional arrangement, associated with the tort reform movement seeking to institute caps on punitive damages.

I am a physician who was repeatedly misdiagnosed with my mental status decrements repeatedly termed psychosocial instead of the encephalopathy that was eventually identified. The long history impacted my claim on two long term disability insurance policies and my ability to protect myself within a legal marriage. Fortunately, I did not commit any major medical malpractice although this certainly was one of the risks.

My attorney during the divorce failed to ethically deal with his conflicts of interest, being a key person in the Republican Party of Texas's game plan to achieve constitutional limits on punitive damages. He, and other politically connected attorneys, set me up with attorneys who had major conflicts of interest with the insurance industry. I eventually left Texas under duress after approaching the FBI, U S Post Office, and the Travis County District Attorney's Office for investigations regarding whether I was also set up for




surveillance after someone sent in fraudulent medical claims from my medical office. The stalking from which I fled has not ceased.

If the plaintiff's bar needs a case that brings the public's attention to the extent the insurance industry is willing to go to manage their financial risk, this is it. Since I behaved ethically consistently, it will also raise the profile of those few physicians who have spoken out against industry control of my profession. I hope to have my case used to question the insurance industry and pharmaceutical industry involvement in missed diagnosis and the extraordinary cost of medical care in the United States. That has the potential to open up new areas of litigation. This will raise the respect profile for attorneys.

If you Google my name and check my wordpress blog under [cynthiajeanneleemd](#) you will find that I have reasons to believe that the U S government is willing and able to stifle access to attorneys. Interestingly, a number of "attorneys" have absurdly asserted that, after being stalked out of Texas and up through the western USA, I only have a Texas case.
