


I write seeking consideration for representation. I believe there is pharmaceutical industry control over both the education and licensing of our physicians in order to force physicians into prescribing their synthetic substances. This control is being reinforced by government collusion with private business entities. This prescribing is being fostered by alterations in textbook coverage of widely under diagnosed, but highly critical areas of medicine such as obstructive sleep apnea. I began to understand this after I, as a licensed practicing physician, was unable for almost 10 years, to be accurately diagnosed resulting in major health problems and multiple legal situations.

At one point, my attorney asked me to become an expert witness on this issue. I began experiencing discrimination and refusals of provision of medical services. After asking the FBI and the U S Postal inspectors for an investigation because my office began receiving insurance checks that could only be the result of fraudulent insurance claim submissions, I was stalked out of Texas.

After being denied access to the courts in Texas in regards to several lawsuits that would have highlighted the misdiagnosing, it is clear this is collusion between the insurance industry and the government to decrease lawsuits about this issue. I am approaching you and your firm because of the value Mr. Lee places on the first amendment rights of physicians in his online publication written with Dr. Gil Mileikowsky, MD. I reviewed

your biography and believe a class action may be appropriate. My somewhat complicated case, which I do not fully describe here, can be used to tease apart the various connections thus setting the stage for the other victims in this scam to be able to pursue justice and financial relief by way of individual filings or class actions.
