Dear Mr. Redmond,

I write seeking representation for insurance bad faith associated with medical misdiagnosis and obstruction of access to the courts necessary for this bad faith to occur. My efforts to obtain investigation from the FBI of the role insurers played in sending in falsified patient insurance claims in my name (dba Mopac Medical Care) resulted in stalking that drove me from my homestead in Texas eventually to shelters in San Francisco. I am approaching your firm because of the advertisement in the Irish Times. I believe my case will permit an investigation of the role that multinational insurance companies and their re-insurers are playing in illegal subterfuge utilizing Federal resources for surveillance to prevent the first amendment right of access to the courts.

In the late 1980's, Farmers Insurance Group was obtained by British American Tobacco (BATUS), an old company that played a part in British imperialism. This company was merged with Zurich Insurance Company and now operates as a subsidiary of Zurich Financial Services. Farmers is now the 3rd largest property casualty insurer in the US. It is not well understood by the American public that insurance companies have been collecting and potentially storing information about them for decades. I believe certain companies may now comprise part of the surveillance system maintained by the multinational interests that increasingly control the U S government.

.In the early 1990's, as documented in the book Delay Deny Defend, major insurers developed tactics to send increasing numbers of their clients' identities to law enforcement, asserting that these clients were suspected of engaging in insurance fraud. The criteria utilized were specious per the author, law professor, Jay Feinman and resulted in a large increase over prior reported names. After a certain number of unusual occurrences in Texas, it occurred to me that these companies could manufacture incidents to create a profile to assist in targeting individuals engaged in whistle blowing on other politically connected companies.

By late 1999, I was at odds with not only Farmer's insurance but also two disability insurers, Prudential and Paul Revere, over long term disability policies. The Prudential plan was through a group policy under the Texas Medical Association. I had been covered by Farmer's for greater than 10 years after following an agent over from a different company in the late 1980's. In 1999, I received a call from them asserting they considered me suspicious for engaging in insurance fraud regarding a mold claim at my home but never received any paper work so asserting. A fourth company I was at odds with is a company that I, like the other physicians insured for malpractice, was a shareholder, Texas Medical Insurance Liability Trust. This company, highly involved in the tort reform movement in Texas, had access to information about me being misdiagnosed by other physicians resulting in potentially huge damage claims (due to the existence of a latent birth defect, a craniofacial anomaly resulting in severe sleep apnea). They were aware that I was disenchanted with the amount of misdiagnosing I saw occurring by many physicians related to missed sleep medicine diagnoses resulting in psychiatric drugging. In my case, I was additionally compromised by having been represented by Donald Patrick MD JD during a divorce at the time my misdiagnosis, resulting in hypoxic encephalopathy, was documented. Dr. Patrick was a key tort reform figure in the Republican Party of Texas. He subsequently became the Executive Director of The Texas State Board of Medical Examiners (now, Texas Medical Board). He engaged in numerous acts of malfeasance over a long period of time that I failed to understand at the time of because of mental status issues, of which he should take some responsibility due to harassment of my physicians.

This Board is now embroiled in a Federal case alleging violations of due process and conflicts of interest dating from Dr. Patrick's time in office.

I have had a number of experiences suggestive of federal obstruction of mail, telephone contact, and Internet services. In addition, many documents have disappeared, even from a safety deposit box. Approaching large firms or nonprofit legal entities have often resulted in no response. However, I think there is a distinct probability that many prominent attorneys have come to terms with insurance industry domination and are cooperating in unethical ways with them. That would explain why attorneys who advertise they specialize in defense took my cases in Texas under the guise of being plaintiff's attorneys and threw my cases, after being referred from other attorneys. It would explain why two prominent attorneys in Oregon hid their government affiliations from me while briefly accepting representation but would not protect me from the stalking.

In summary, I am looking for a firm that understands the historic struggles that peoples of many cultures have had with domination from vested interests. This is a very hard case. It will require networking and finesse to find allies and amicus. These are treacherous waters and treacherous times due to the probability of federal monitoring of communications, if no other reason. I am a sincere individual having had to make difficult decisions such as leaving my child behind in Texas, a King Solomon decision if there ever was one. This case would bring a great deal of publicity to the area of Federal agencies/contractors and their role in protecting vested interests instead of the people.
