Dear Mr. Rude,

I have been researching attorney profiles and I am asking for representation. I read that you represented Dr. Patrick Campbell of Redding on a whistleblower issue in contention with the Department of Justice. My need for representation is similarly complex.

I first attempted to locate an attorney for an issue related to pharmaceutical malfeasance in the mis-education of physicians regarding confusion between patients with organic diagnoses being mistaken for psychiatric conditions many years ago. Such mis-education causes increased pharmaceutical industry profits and never benefits the patients. At the time, I was in litigation with the State of Texas and two major insurance carriers and have very good reasons to believe any correspondence between me and attorneys was not only monitored but it was certainly possible for communication to be disrupted. Even mail between me and a federal court was disrupted (or, at least, never received). I was eventually stalked out of Texas leaving no one legally in charge of dealing with these issues at critical times. Since then, I have tried to approach the Department of Justice directly on the qui tam issue of pharmaceutical industry malfeasance. I have received no response. I have also approached qui tam firms. Some I have never heard back from but Philips and Cohen sent me a response suggestive of there already being in existence a suit of this type. Since my suit, if it had not been obstructed by governmental control of our communications, would have probably preceded any current suit, I am seeking

experienced counsel on this issue. This is a case where the DOJ would possibly be a party to the malfeasance.

Meanwhile, I have made many attempts to contact large issue driven nonprofit legal groups to no avail. Most typical, is to receive no reply whatsoever suggesting that my communications are not being received.

I look forward to your reply.
